College to the dead end. Turn left onto Main Street and stay in the right lane. Go about one block and at the fork in the road bear right over the railroad tracks following signs for Route 896 north. Proceed straight through the traffic light at Cleveland Avenue. Look for an electronic sign and a sign for the University of Delaware – Laird Campus on the right. Turn right after the electronic sign. Clayton Hall is on the right. The parking lot is on the left.
