SUBJECT: Modified Financial and TRRP Procedures for Reporting of Certain Allocated LAE Payments from Hurricane Katrina

REFERENCE: W-05054, Hurricane Katrina – Flood Claim Handling Standards

As a follow-up to WYO Company Bulletin #05054, Hurricane Katrina – Flood Claim Handling Standards, modified procedures for both financial and statistical reporting are being developed and will be distributed next week. These changes will be effective immediately upon receipt.

WYO Companies will need to implement the modified procedures before submitting the October 2005 financial and statistical information. The changes will be minimal, to include a new worksheet for financial reporting, and three new options for the “Cause of Loss” data element for TRRP reporting.

To facilitate proper financial tracking for Hurricane Katrina claims for the September 2005 reporting period, please use the attached Interim Financial Worksheet. This document should be completed and submitted with your monthly financials to financials@nfipstat.com by noon ET on Thursday, October 20, 2005. Additional instructions will be provided for handling statistical and financials for the October 2005 reporting period and beyond.
